## SECTION 4: FIRST AID MEASURES

<b>Eye:</b>	For eye irritation. Remove contact lenses. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.
<b>Skin:</b>	For itching or burning of the skin. Immediately flush the skin with plenty of water while removing contaminated clothing and shoes. Get immediate medical attention. Wash contaminated clothing before reuse.
<b>Inhalation:</b>	For nasal irritation, headache, dizziness, nausea, vomiting, heart palpitations, breathing difficulty, cyanosis, tremors, weakness, red flushing of face, irritability, Seek medical attention. Remove exposed person from source of exposure to fresh air. If not breathing, clear airway and start cardiopulmonary resuscitation (CPR). Avoid mouth-to-mouth resuscitation.

## SECTION 5: FIRE FIGHTING MEASURES

<b>Suitable Extinguishing Media:</b>	Use water spray, carbon dioxide, fog, foam, or dry chemical as required by surrounding fire.
